1.1 Purchase Link

This link contains the first release of a new GMSU/QC major version (e.g. 6.0.0).

1.2 Bug Fix Link

This link contains all minor releases of the current version (e.g. 6.0.1). Customers should check this link for the most recent release of the current version.

Licenses come with a 60-day warranty during which the customer has free access to the Gubbs Inc GMSU/QC download site. After 60 days, customers must purchase a Yearly Maintenance Contract (see Section 2) to maintain access to the download site.



When determining the number of licenses to purchase, remember to take into consideration that GMSU/QC can be configured in multi-user mode, allowing users to install and GMSU/QC at his/her office workstation to process data located on a data acquisition workstation or located on a network server.
